**Background information:**

Spain has had a proactive migration policy in place since September 2013. It makes our country more attractive for mobile people with talent and for business.

The new regulation is a business friendly framework of visa and residence and work permits designed with the aim of attracting and retaining talent, investment and business.

The European Agenda on migration states the positive contribution to economic growth of entrepreneurs, investors and highly qualified professionals.

In the same sense, the Communication from the Commission to the European Parliament, the Council, the European Economic and Social Committee and the Committee of the regions of 28th of October of 2015, among others, indicates that rules on attracting entrepreneurs, combined with support measures helping them to operate in the Single Market, could make Europe a more attractive destination for innovators from outside the EU.

Spain is now reviewing its migration policy and the fees of certain categories regulated in Law 14/2013, of 27 September 2013, on support for entrepreneurs and their internationalisation and would like to know how a rate hike could affect the number of applications that are submitted.



Spain NCP considers that collecting information about the fees from other MSs is crucial for a correct analysis of a matter and will help to policy makers to make a decision.

	<b>Austria</b>	Yes	<p><b>1.</b> In accordance with the Austrian Act on Fees several fees are due in connection with granting a residence title pursuant to the Settlement and Residence Act (there exists no residence permit for investors in Austria). These fees are: - increased “application fee” in the amount of € 120,00 (Article 14 fee item 6 para 3 subpara a Act on Fees) - “granting fee” in the amount of € 20,00 (Article 14 fee item 8 para 4 subpara 1a Act on Fees) - Personalization costs in the amount of € 20,00 (Article 14 fee item 8 para 4b Act on Fees).</p>
	<b>Belgium</b>	Yes	<p><b>1.</b> When applying for certain residence permits there is a mandatory fee foreign nationals have to pay. Foreign nationals need to pay such a fee in order to cover the administrative costs related to the processing of the residence permit application. The payment of the fee is an admissibility criteria for the application for certain residence permits. For the categories mentioned in the above question the fee is 350 EUR. There is one exemption to this rule in these categories, no fees need to be paid by researchers who were allocated a scholarship by the authorities or a specific institution AND the researcher need to have signed a guest agreement with a recognized Belgian research institution. The fee for the actual residence card that can be obtained at the municipality is 19,20 EUR (the fee for an urgent procedure is higher). On top of this the municipalities have the possibility to collect a fee when foreign nationals apply, renew, extend, or replace certain residence permits (the actual card), in order to cover the costs related to the processing of the application of these cards. Municipalities can chose to collect this fee or not, and can determine the amount of the fee (within a fixed limit). Municipalities can request this fee for the certificate of registration in the Registry for foreigners-temporary stay (residence card type A – this type of card will be obtained by all categories mentioned above except for highly qualified, they will obtain a residence card type H). The maximum amount of the fee that the municipalities can request is 50 EUR (on top of the fee covering the production costs of the residence card). For the type H card municipalities can request a fee that is not higher than the fee that is requested from Belgian nationals (differs from municipality to municipality, mostly around 20 EUR). The municipalities can only request this fee once a year</p>
