



EMN ASYLUM AND MIGRATION GLOSSARY

The European Migration Network (EMN) Asylum and Migration Glossary is a key resource for the most up-to-date, relevant and accurate terms and definitions as well as reliable and verified translations related to migration and asylum, accessible to all interested stakeholders.

The EMN Glossary offers an EU-wide multidisciplinary vocabulary of over 540 terms and concepts in 27 European languages.

A consultative approach is used to ensure its relevance and accuracy. The EMN Glossary is developed by a dedicated working group which collaborates with experts from various EMN National Contact Points (NCPs) and key EU bodies, including the European Commission, the European Union Agency for Asylum (EUAA), the Fundamental Rights Agency (FRA), the European Border and Coast Guard Agency (Frontex), and EU Council institutions, as well as international organisations, such as United Nations High Commissioner for Refugees (UNHCR) and International Organization for Migration (IOM).

GLOSSARY APP

The EMN Glossary app offers convenient access to terms translated into 27 languages, with browsable definitions in seven full language versions (English, Finnish, French, German, Greek, Italian and Latvian). The app features alphabetical search, browse functions for the terms. as well as visual navigation of the relationships between terms.

BETTER COMPARABILITY **OF TERMS**

The EMN Glossary provides clear and harmonised definitions of migration and asylum concepts, supporting evidence-based policymaking and enhancing a common understanding across the EU and at national level. It intends to streamline communication for policymakers, practitioners, media, and people interested in the topic of migration and asylum.

UP-TO-DATE TERMS AND TRANSLATIONS

The EMN Glossary reflects recent developments in migration and asylum, including those related to the Pact on Migration and Asylum. Through regular updates, it stays aligned with the Pact's implementation across both internal and external dimensions in order to meet the needs of migration professionals. The Glossarv includes verified national translations of the terms in nearly all EU languages as well as in several non-EU languages, supporting EMN Observer Countries and expanding its reach.

CLEAR METHODOLOGY

The EMN Glossary uses a structured, hierarchical approach to defining terms, giving priority to EU acquis sources while also incorporating relevant sources from various contexts. Given the complexity of language, it identifies preferred terms, synonyms, and term relationships, with contextual notes to enhance understanding across different disciplines and perspectives.

USER FRIENDLY AND EASILY ACCESSIBLE

The EMN Glossary is available as an interactive online glossary via the EMN central and national websites, as a printed edition, as well as a mobile application for download by Android and iO5
