

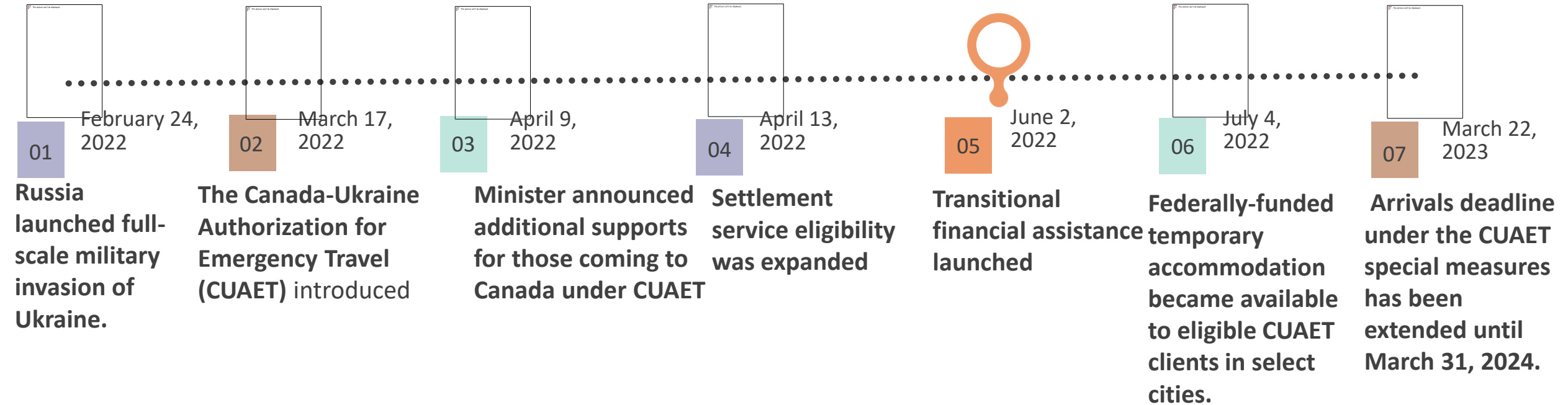

Responsive Immigration Measures

CUAET is open to Ukrainian nationals and their family members both inside and outside Canada.



Outside Canada:

- ✓ Fee-exempt applications
- ✓ Visas allowing for multiple entries to Canada
- ✓ Valid for up to ten years (or matching the validity of passport)
- ✓ Ability to apply for an open work permit or study permit



Inside Canada:

- ✓ Ability to extend their stay
- ✓ **Ability to apply for an open work permit** if they are on (or are able to restore) temporary resident status.
- ✓ **Ability to apply for a fee-exempt study permit** if accepted to a designated learning institution in Canada and complete an immigration medical exam, if required

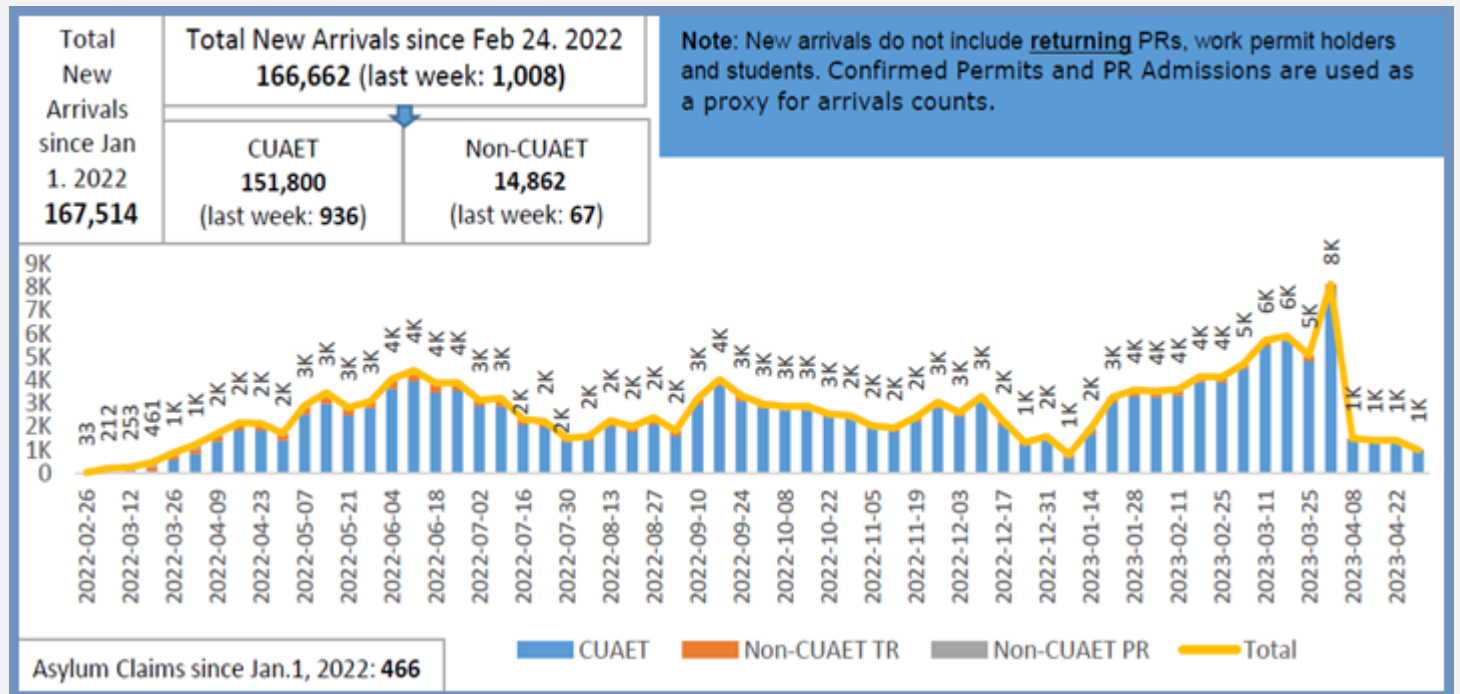
Key Figures Regarding CUAET since March 17, 2022:

As of May 2, 2023, IRCC received CUAET applications from close to 1.03M individuals.

Applications of over 717,500 individuals have been approved (698,000 overseas applicants and 19,500 in-Canada applicants).

Over 150,000 CUAET holders have already arrived to Canada from abroad and another 19,500 individuals were approved for CUAET in Canada.

Transitional financial assistance



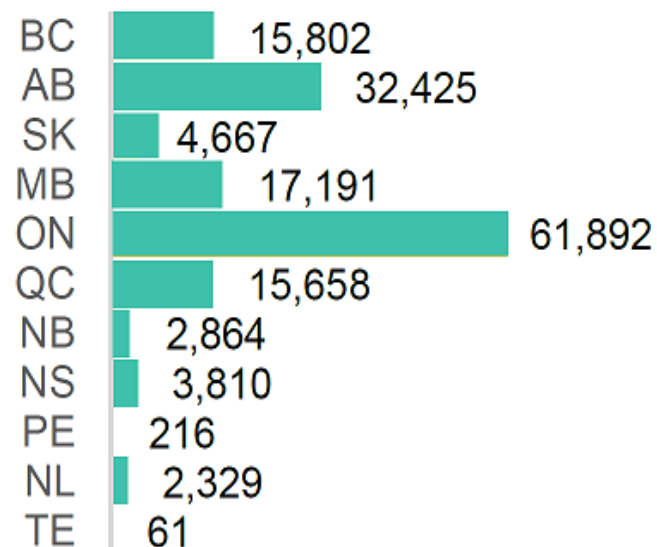
On June 2, 2023, IRCC launched Transitional financial assistance under the Canada-Ukraine Transitional Assistance Initiative (CUTAI).

The benefit consists of a direct one-time payment of \$3,000 CAD per adult and \$1,500 per child (17 years and under).

The application process and distribution is managed by Employment and Social Development Canada

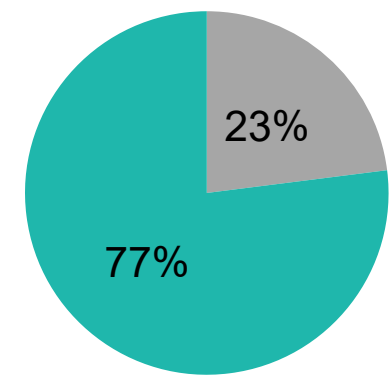
As of April 30, 2023, over 157,000 CUAET holders were approved for CUTAI payments.

Temporary accommodation

In July 2022, the Department secured a total of 100 rooms in three cities: 75 rooms in Toronto, 15 in Calgary and 10 in Vancouver.

In January 2023, the Department expanded to offering federally-funded temporary accommodation in Moncton, NB (5 rooms). The number of rooms in other locations was also amended based on demand and as of March 16, 2023 there are 905 in federally-funded hotels across 10 cities.



In October 2022, the Department expanded from having federally-funded hotels in 3 cities to 9 cities. Locations include: Vancouver - 50 rooms; Calgary - 75 rooms; Edmonton - 25 rooms; Saskatoon - 25 rooms; Winnipeg - 50 rooms; Toronto - 200 rooms; Ottawa - 25 rooms; Halifax - 25 rooms; St. John's - 25 rooms.

As of May 2023, there are 810 rooms in federally-funded hotels across 10 cities: Vancouver - 65 rooms; Calgary - 75 rooms; Edmonton - 25 rooms; Saskatoon - 10 rooms; Winnipeg - 50 rooms; Toronto - 500 rooms; Ottawa - 25 rooms; Moncton - 5 rooms; Halifax - 30 rooms; St. John's - 25 rooms.

Eligible applicants who are outside Canada have **until July 15, 2023** to apply for a visa under CUAET.

CUAET holders in Canada have **until March 31, 2024**, to apply to extend or change their temporary status in Canada through the special measures.

Settlement services that are normally reserved for permanent residents of Canada will continue to be available to all Ukrainians and their family members **until March 31, 2025**.
