# ALGORYTHM OF THE RECEPTION OF UA REFUGEES



- More than 50% of UA refugees are being accommodated in private houses (10% provided by state institutions and municipalities).
- App. 30 000 people were accommodated in private housing through the civic initiative "Strong together"






### Hub of institutions&services:

- Police department (coordination, risk management, prevention etc.)
- Municipality (social welfare, accomodation etc.)
- Mobile groups of Migration department (registration, permits etc.)
- State institutions (emergencies and health services, employment, children rights protection, psychological and emotional support etc.)
- NGOs (humanitarian aid, accomodation etc.)
- The paramilitary organisation Riflemen's Union (security of entrance, public order)

# **VARIOUS SCENARIOS**

### Low flow scenario:

- 1 registration center
- 7 registration centers

# High flow scenario:

- 1 registration center for individuals
- Public places for massive accommodation with mobile migration services (add.up to 30 000)

### Present scenario:

- No RC
- 1 hotline, all services are provided in municipalities





### SITUATION IN NUMBERS

- In total **77 231** (out of them **26 308** children up to 18)
  76 421 temporary protection; 104 national visa; 12 asylum; 492 non-visa;
  46 legal status changed; 156 medical treatment; left/no possibility to contact 6504.
- Valid TPP 46 345, out of them digital TPP 39 630, declined TPP 3134, terminated TPP 52.
- Since the war **25 256** employed (high qualified 8.2%, middle qualified 73.1%, low qualified 18.7%, majority 30-49 years old), unemployed 3201 (majority women).
- For very long time Lithuania was #3 in EU for Ukrainian refugees per capita.



# THE OPINION OF THE INHABITANTS OF LITHUANIA/18-74

The ones who wouldn't accommodate are in doubt about their own future, finances, practical reception issues etc.




